3. Hazardous Materials release (accidental or intentional).







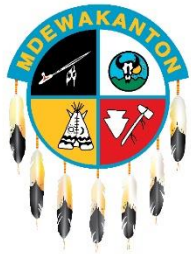
# Public Safety Operations

- A Unified Command Group has been established between Mdewakanton Public Safety, SMSC Conservation and Enforcement, Mystic Lake Security and Surveillance, Prior Lake Police and Nomadic Security.
- An increased Public Safety presence will be noticed throughout the Gaming Enterprise.
- Heavy traffic expected throughout the SMSC. Expect delays throughout the afternoon into the late evenings of the 4 nights Nomadic is in operation.

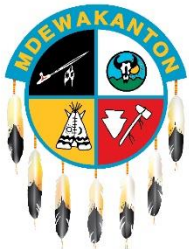

# Purpose

- Event safety
- Preserve life and property
- Assist with providing the best flow of vehicle and pedestrian traffic
- Work with our public safety partners to accomplish our goals.
  
- Our mission is to provide a safe, enjoyable, orderly and secure environment for a successful event.



# Mutual Aid

- 60 Police Officers from area agencies.
  - 40 to 48 commitments from Scott County agencies.
  - Commitments from Dakota and Carver Counties are in process to fill the remaining 12 to 20 assignments.
  - Approximately 20 squad cars will be utilized.
  - Relief personnel are built into the plan.
- Joint Powers Agreements
  - City of Prior Lake and Mystic Lake's JPA's are completed
  - Other cities in Scott County and other agencies will soon be reviewing and signing.
- Partnerships with Surrounding law enforcement agencies, Mdewakanton Public Safety, Mystic Lake Security and Surveillance, and SMSC Conservation.





# Mutual Aid (cont'd)

- Transport cars from Scott County
  - 2 committed
  - Will assist with transporting arrests to jail and detox
- Scott County Sheriff's Office is providing their Crime Analyst for the event.
  - Monitor social media
  - Develop and share intel on current LE sensitive threat assessments
- Mdewakanton Fire's Threat Analyst will be providing threat assessments as well.



# Event Management

- Unified Incident Command System for Nomadic event
  - Prior Lake Police Department
  - Mdewakanton Public Safety
  - Mystic Lake Security and Surveillance
  - SMSC Conservation
  - Nomadic Security
- Unified Command
  - Centralizes decision making for all major security and safety issues.
  - Centralizes coordination of police, fire, security and medical
  - Allows for a clear exchange of information



# Other Considerations

- Prior Lake PD will be handling calls for service in town and at Mystic Lake
  - There will be more activity, more partying, more drinking, more calls and more traffic.
  - Mystic Lake will be busier, generating more calls for PLPD.
  - The majority of PLPD personnel will be dedicated to responding to calls in town and at Mystic.



# Still planning.....

- Joint Powers Agreements for partnering agencies signed and total numbers of officers confirmed for event
- Training scheduled for January 31, 2018 at Mystic/Nomadic
- Club Nomadic Law Enforcement Guide is in process to provide all officers working the event with important information and guidelines for doing their jobs.
- There will be daily briefing sheets with updated threat assessments as well as daily rosters with assignments.
